

Terms and Conditions of «Your Vision of Lucta» Photo Contest

«Your Vision of Lucta» Photo Contest, launched by LUCTA, S.A. in collaboration with Fundación Foto Colectania, is subject to the following terms and conditions. Participation in the contest entails full acceptance of the same.

1. Theme

All images should be based on your vision of Lucta. We seek a personal and creative perspective that can surprise us, so we encourage you to participate, taking photos of moments, people or aspects that best define our enterprise. It does need to be related to the facilities or elements of Lucta. It can also be a picture of a landscape or of an experience or situation that evokes Lucta.

2. Participants

Any employee is eligible to participate in the contest. Employees are all persons who on October 1, 2018 have a direct employment contract with a company of the Lucta Group.

3. Deadline

Photographs can be submitted from October 1 to November 16, 2018, 11:59 PM, CET.

4. Prizes

The panel will shortlist 30 photographs, which will be considered as finalists. The shortlist will be published on December 11, 2018. From among these finalists, the panel will select the winning photographs, which will be awarded the following prizes:

1st prize: 3,000 euros
2nd prize: 2,000 euros
3rd prize: 1,000 euros

The 3 winning photographs will be announced on December 18, 2018.

5. How to participate

Each participant can submit <u>only one photograph</u>, which must be sent in digital format along with a registration form duly completed, available on <u>www.lucta.com/photo-contest.</u>

You must also provide a title for the photograph and the year it was taken. You may also include a short description of the image and the reason why you chose it.

The organisation shall acknowledge receipt of the submitted photographs. Lucta or Foto Colectania will not take any responsibilities for any lost photographs, late or undelivered submissions, whether this is due to technical issues affecting electronic communications or to other reasons.

6. Format

All works must be submitted in digital format through the submission form. Photographs can be taken either with film cameras, digital cameras or mobile devices. Photographs can be black and white or color. They can also be edited using image processing software.



7. Panel

The panel will be composed of:

- Mr.Pepe Font de Mora, Director of Foto Colectania
- Mrs.Irene de Mendoza, Art Director of Foto Colectania
- A Lucta representative

Each photo will be judged based on the following criteria:

- Originality and creativity
- Artistic and technical quality

The panel's decision will be taken without knowing the authorship of the photograph.

No complaints will be accepted in regard to the results. The panel's decision will be final.

8. Copyright

All photographs must be original and unpublished works. The participant must be the author and only holder of the copyright of the photograph.

Participants authorize the contest organization to reproduce, distribute and publicly communicate the submitted photographs, in order to promote the ideas and values of this contest. Whenever a photograph is used for promotion activities, the author of the photograph will be given credit.

9. Image rights

Participants must obtain written consent from all the individuals over the age of 18 who can be recognized in the photograph. In the case of minors, written parental consent must also be obtained.

Participants are responsible for guaranteeing they have obtained all necessary consents and permissions to submit their images to the contest. You can download a Declaration of Consent here and, once filled, send it to info@fotocolectania.org.

10. Processing of personal data

Personal data provided by the participants shall only be used for the purposes of this contest. Participants agree that their names be disclosed for these purposes. Personal data will be processed on the basis of the consent of the participant in compliance with the data protection regulations, under the supervision of Lucta, S.A.
